

Annual Public Notification of Non-Discrimination in Career and Technical Education Programs

Allied Health: Health Information Technician, Massage Therapy, Medical Assistant, Phlebotomy	High School Diploma or GED, WorkKeys Skills Assessment, background check, physician release, immunizations (except for Massage Therapy), interview with the Coordinator
Business: Certified Administrative Assistant, IT-Computer Systems & Networking	High School Diploma or GED, WorkKeys Skills Assessment, interview with the Coordinator
Cosmetology: Cosmetology, Nail Technician	High School Diploma or GED, WorkKeys Skills Assessment, interview with the Coordinator
Industrial Trades: Automotive Technician, HVACR-Heating, Ventilation, Air Conditioning, Refrigeration, Maintenance Technician, Welding Certification	High School Diploma or GED, WorkKeys Skills Assessment, interview with the Coordinator
Nursing: LPN to RN Transition	State issued picture id, proof of U.S. Residency, High School Diploma or GED, WorkKeys Skills Assessment, pre-entrance ATI-PN testing, math prerequisite, LPN licensure, professional reference, medical release, background check, drug screen, immunizations, interview with the Coordinator
Nursing: Practical Nursing	State issued picture id, proof of U.S. Residency, High School Diploma or GED, WorkKeys Skills Assessment, STNA certification, professional reference, medical release, background check, drug screen, immunizations, interview with the Coordinator
Nursing: STNA	State issued picture id, proof of U.S. residency, WorkKeys Skills Assessment, professional reference, medical release, background check, immunization, interview with Coordinator.
Public Safety: EMT, Fire	High School Diploma or GED, WorkKeys Skills Assessment, interview with the Coordinator
